Fees include the \$3 American Kennel Club event fee and a .50 recording fee.

Entries close at noon on Wednesday, March 7, 2012 unless the numerical limit is reached prior to this date, after which time entries cannot be accepted, cancelled, altered, or substituted, except as provided for in Chapter 11, Section 6 of the Dog Show Rules.

No move ups for Rally will be allowed.

Entries will not be accepted if received without signatures, fees and back of entry form with agreement. An official AKC entry form must be used. Photocopies of front and back will be accepted if legible. No entry will be accepted which is made subject to conditions. Exhibitors whose checks are returned for NSF will be subject to all bank fees and a \$5.00 handling fee.

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by a judge, or barred from competition by action of the trial committee. If, because of riots, civil disturbances, fire, an act of God, public emergency, acts of public enemy, strikes, or any other acts beyond the control of GRKC, it is impossible to open or complete the trial, no refund of entry fees will be made.

Dogs need be present only for their scheduled time of judging and may be excused immediately after judging unless required for further judging. Dogs will be judged in catalog order, to the extent that it is practical without holding up judging in another ring. Judges are not required to wait for dogs and it is the responsibility of each exhibitor to have his/her dog ready at ringside without waiting to be called.

Dogs owned by show chair, members of the show committee and members of their households will not be eligible for entry at this show.

Bitches who come in season after the closing date will have the entry fee less \$5.00 refunded upon written certification by a licensed veterinarian to the effect that the bitch in question is in season on the day of the trial. Notification must be received by the trial secretary before 8:00 a.m. (CST), Friday March 23, Saturday, March 24 or Sunday, March 25, 2011.

No dogs will be allowed into the trial grounds except those properly entered.

No exercise pens or crates are permitted in the building at any time.

If you wish to purchase a catalog, please pre-order with your entry for only \$4.00 for both trials. Only a limited number of catalogs will be available at the trial for the cost of \$5.00

Directions to the Show Site:
